US Postal Money Order

Gold must be minted between 1850 and 1932. We will only accept lightly circulated coin, preferably About Uncirculated (AU), Very Fine (VF), or Extremely Fine (XF) grade. Valuation will depend on the total amount of the order. We do not accept bullion bars or coin.
